The National Institutes of Health is looking for contractors for the CIO-SP4 contract, an acquisition agreement for IT services, to take healthcare technology development to the next level, which is expected to be worth \$50 billion. The preceding phase of the contract, CIO-SP3, focused on improving 10 key efforts, including:

INFORMATION SECURITY



DIGITAL GOVERNANCE

The NIH has extended the CIO-SP3 contract until April to ensure that services will not lapse during the initial award of the CIO-SP4.





The U.S. Department of Health and Human Services seeks to develop professional, scientific and technical services to support the National Institute of Allergy and Infectious Diseases' upcoming research priorities through a contract with an expected value of \$3 billion. The contract includes support in critical research areas, including:

The selected government contracting organization will provide services in microbiology, molecular biology, biochemistry, infectious diseases, immunology, bioinformatics and vaccine research to enhance understanding of immune responses and to develop new vaccine targets for HIV/AIDS.







The Administration for Children and Families within the Department of Health and Human Services has released a special notice concerning the agency's long-range acquisition elements for the upcoming year. The Specialized Contracting & Procurement Directorate under Government Contracting Services will look to provide contracting assistance to numerous ACF mission partners, including:

- THE IMMEDIATE OFFICE OF THE ASSISTANT SECRETARY
- OFFICE OF HUMAN SERVICES AND EMERGENCY PREPAREDNESS AND RESPONSE
- OFFICE OF LEGISLATIVE AFFAIRS AND BUDGET

Current forecasts predict contract action to exceed \$250,000 with expectations being updated periodically throughout the year.
